



# 2018 Valley Legacy Award Nomination Information

*The Valley Legacy Award honors individuals who demonstrate an ongoing commitment to the community and serves as an inspiration to others.*

## Eligibility

---

- Nominee must be a resident of the Mahoning Valley
- A nominee is limited to nomination in two consecutive years then must sit out for two years before being nominated again in any category.
- **Nominations must be received by July 19, 2018.**

## Nomination Procedure

---

- Complete the nomination form with specific, detailed and precise examples in response to the guidelines to assist the judges in choosing the winner.
- The completed application should be no longer than four pages, including the two requested letters. Additional documentation should not be more than two pages for a total of six pages.
- Give different perspectives – don't tell the same story three times!
- Don't just say your nominee is outstanding, prove it with documentation.

## Selection

---

- A committee of judges including community leaders and past award recipients will review the nominations
- All nominees will be recognized at the Valley Legacy Luncheon on October 10, 2018. The award winners will be announced at the luncheon

*The Outstanding Senior Valley Legacy Award honors individuals who demonstrate an ongoing commitment to the community through his or her professional activities and serves as an inspiration to others.*

### **Evaluation**

This Award is specifically for the consummate professional who has, through the years in their profession, demonstrated an ongoing commitment to improving life for Valley Seniors. They must meet the following criteria:

- Nominee must be 60 or older by June 1, 2018
- Nominee must have excelled in their profession and show demonstrated improvements achieved for underserved Senior populations of the Mahoning Valley through actions within their profession
- Extension of their professional experience contributing to the community and not receiving any remuneration for those professional services
- Is a recognized service leader outside of their professional community

### **Evaluation**

---

This Award is specifically for that individual who has distinguished themselves in the community through their volunteer service, having made a difference in the lives of all involved.

- Nominee must be 60 or older by June 1, 2018
- Nominee must have shown exceptional commitment to their community **separate** from any professional involvement.
- Fostered improvement to the Mahoning Valley through their volunteer civic engagement
- Provide leadership within the community; will have served to influence decision-making and show demonstrated improvements achieved for underserved Senior populations of the Mahoning Valley
- Demonstrate the scope of impact their volunteering had on the community

3. Who benefits most from this nominee's service? What motivated them to become involved?

## **2018 Outstanding Senior Advocate**

*The Outstanding Senior Advocate Valley Legacy Award honors individuals who demonstrate an exceptional effort to assist seniors through professional, volunteer or civic activities.*

### Evaluation

---

**Advocacy** in all its forms, seeks to ensure that seniors, particularly those who are most vulnerable in society, are able to: Have their voice heard on issues that are important to them. Defend and safeguard their rights. Have their views and wishes genuinely considered when decisions are being made about their lives.

Nominees are evaluated on the following criteria:

- Demonstrated significant support and advocated for senior citizens civically and/or professionally beyond regular job responsibilities. Clearly outline the impact.
- Provided leadership within the community and shows demonstrated improvements achieved for underserved Senior populations of the Mahoning Valley (must be both identifiable and quantifiable)
- The nominee will have served to influence decision-making and demonstrate the scope of impact their civic involvement has had on issues affecting seniors

3. How has the nominee been involved in activities that support senior citizens and what does 'advocacy' for seniors look like coming from this person?
